WILL MY DEPOSIT OR LOAN ACCOUNT NUMBERS CHANGE?

No, we are pleased to share all bank account numbers will remain the same!



WILL I NEED TO CHANGE MY DIRECT DEPOSITS/PAYMENTS?

The SCB routing number can be used for direct deposits/payments for a period of time. After December 8th, we suggest you provide your new routing number to any direct deposit or payment vendors within 12 months.



HOW LONG CAN I USE MY SCB DEBIT CARD?

Here are the key dates for your debit card:

- By Dec. 3rd: New C&N card delivered
- Dec. 6th: First day to activate C&N card
- Dec 7th: Final day to use SCB card
- Dec 8th: Begin using your new C&N card
