

## 2010 Calendar Photo Contest Rules and Entry Form



Citizens & Northern Corporation, parent company of Citizens & Northern Bank, First State Bank and Citizens Trust Company, is looking for images that capture the beauty of its market area of Bradford, Cameron, Lycoming, McKean, Potter, Sullivan and Tioga Counties in Pennsylvania and the Canisteo-Hornell region of Steuben County in New York. A total of 13 photos will be selected - one for each month - and the Grand Prize winner, which will be published on the calendar's cover. 
***Only amateur photographers are eligible to enter our contest.***

## 2010 PHOTO CALENDAR CONTEST RULES

1. All entries must be postmarked by midnight, August 2, 2009, and be accompanied by an entry form. Entry forms are available at all Citizens & Northern Corporation offices and on our websites.
2. All photos must have been taken by amateur photographers. C&N Corporation employees and their immediate families are not eligible to enter our contest.
3. **Entrants will be limited to four photos.** No more than four photos per entrant will be accepted. Entries must be mailed to the address on the entry form. We will not accept framed photographs.
4. Winners will be notified in August, 2009. Only entrants providing a self-addressed, stamped envelope of the right dimensions and proper postage will have their photos and CDs returned. Photos will be returned a few weeks after the final selection. Winning entries will be held until the publication of the calendar. Selected images are used on a non-exclusive basis.
5. **ALL ENTRIES MUST BE ACCOMPANIED BY PHOTOGRAPHIC PRINTS,** even if digital images are submitted on disk. NO entries will be accepted via email. Prints should be a minimum of 6X4 and no larger than 10x8. Digital images must be at least 300 dpi (resolution). Digital prints must be accompanied by the 300 resolution files on CD.
6. All entries must be of outdoor themes. Both landscape and close-up photographs are acceptable. **ONLY HORIZONTAL PHOTOGRAPHS WILL BE CONSIDERED.** Photos must fit the 11" wide x 8.5" deep calendar format. Selected photos will be cropped for that format. Photos of people will not be considered.
7. Each entry must be the work of the person submitting the photo, and a signed entry form is required. **All photographs must have the photographer's name and address on the back.** Entrants under the age of 18 must submit a release from a parent or guardian.
8. Entries will be evaluated based on appeal, content, photographic skill and appropriateness for the calendar the month the photos depict. The decision of the judges is final.
9. C&N Corporation assumes no responsibility for submissions. Selected images are used on a non-exclusive basis.
10. Only photographs representing scenes from the C&N Corporation market areas will be considered. C&N Corporation's market areas include Bradford, Cameron, Lycoming, McKean, Potter, Sullivan and Tioga Counties in Pennsylvania and the Canisteo-Hornell area in New York State.
